**The detailed fee structure for examination, other than Exam Fee per Course mentioned above, will be notified at the time of exam registration.*

(a) Students belonging to the SC/ST/OEC categories shall be exempted from remitting Tuition Fee, Exam Fee per Course, Admission Fee, and SLM Fee per semester, subject to the following conditions:

1. They are not employed in Government, Quasi-Government, or Public Sector services;
2. They are not seeking admission to an additional PG degree programme;
3. They have not previously availed fee concession at the Postgraduate level, either through the University or through the concerned Block Panchayat.

However, such students shall remit all other applicable special fees, including Registration Fee, Caution Deposit, and similar charges.

(b) Students eligible for fee concession shall, in addition to submitting the online application, mandatorily apply for the concession through the Government of Kerala's e-grants portal. Failure to apply/register through the e-grants portal shall result in denial of the concession, and the student

shall be liable to remit the full prescribed fee.

(c) Students of the OBC category, foreign nationals, and applicants pursuing an additional PG degree are ineligible for fee concession.

Mode of Remittance- Fee should be remitted Online through the Instant Web Payment System provided in admission portal.
